# The Oxford Liberty Network

Our Oxford<sup>1</sup> Liberty Network is our more focused network for Connecticut employers, featuring network tiering to provide a better balance between costs and employee satisfaction. Members\* enrolled in these plans also have national network access when traveling outside of the tri-state service area.<sup>2</sup> Plus, all Oxford plans include 24/7 doctor video chats, virtual weight loss and wellness coaching, and access to personal benefit advocates to help connect your employees to care — wherever, whenever.

### Access to doctors, hospitals and pharmacies nearby



Tiered Benefits: The Connecticut Oxford Liberty Network has a tiered benefit design for PCP and Specialist office visits.

- A tiered benefit structure that may help employers save on medical premiums
- Members can save on out-of-pocket costs by seeking care from a high-value Tier 1 physician. Members can sign-in to myuhc.com®, go to "Find a Doctor" and then look for Tier 1.
- Members can choose from any provider in the Liberty network but are required to select a PCP to help coordinate care and referrals when needed. Members may select a PCP from our Tier 1 network.



Local access: The Oxford Liberty Network provides access across the tri-state region (Connecticut, New York, New Jersey) with more than 116,000 providers.3


#### **Pharmacy**
